

Respected Members,

We the undersigned applicants are Assistant Professors in Political Science working in law colleges affiliated to the Shivaji University, Kolhapur, after discussion and deliberation in length, wish to recommend to restructure the subjects of 1st and 2nd year of Five years law course.

We have gone through the syllabus in detail, made discussions with each other and come to the conclusion that it is inevitable to restructure the subjects. It is in the better interest of students as well as colleges.

As per existing structure (attached herewith) of subjects at Pre Law (NLC) -I Sem.- I, there is 1 (one) full time lecturer for Political Science- 1 and Political Science- 2 and 1 CHB lecturer for English-1. Political Science lecturer has to attend the pre law-I class continuously as well as absence of lecturer for English-1. If the lecturer of Political Science remains absent then whole Pre law-1st class will remains unattended and that is a big problem for students. Same situation appear at Pre law (NLC)- II Sem. -IV.

It means in Sem. I and II of pre law- I, number of lecturers are 2 and 4 respectively and the same problem is continued in Pre Law -2 year.

Therefore solution over this problem is(attached herewith), there can be replacement of subjects of Sem.-I, II , III , and IV at Pre law I and II.

At Pre law-I ,Sem.-I Political Science-2 (Public Administration) may be replaced by History-I (which is at pre law-1, Sem. 2) and Pre law-II, Sem.-III, Legal history- II may be replaced by Political Science- VI (International Relation) (which is at pre law-II Sem-4). Now number of lecturers will be equal in both Sem.- I and II at pre law I and II.

This change may be started from the AY 2020-21 for both the Pre law-I and II year of Five years law course simultaneously. Kindly approve these recommendations and do the needful.

Suggestions on subject- DSC – 1005 Moot Court, Pre-Trial Preparation And Participation In Trial Proceedings (PAPER – V)

Suggestions -

1. **Need of Moot Court Diary** – Whether Moot Court diary is essential? If yes, its format and contents to be clarified. I think, Moot Court Diary essential to maintain the record of 'Observance of Civil Trial, Observance of Criminal Trial and for Pre-Trial Preparation'.
2. **Moot Court Diary Contents** – Need clarification and uniformity about the contents of Moot Court diary. This diary must have contents other than that of contents for Professional Ethics, ADR and Internship. Diary has to be maintained by every student in hand-written format, signed by subject-teacher and Principal well before the date of viva. I found that, some colleges are asking students to maintain record of documents in a separate file and staff of such college expects that other shall also keep the record in a separate file. I think this is not mandatory and should not be compulsory.
3. **Conduct of Moot Court** – Manner of moot court presentation is to be clarified. There shall have uniformity in conduct of Moot Court as it is a Practical Training Paper. It has to be conducted in practical manner.
4. **Non-zero passing for Viva-** It is found that, there is a non-zero passing criteria for Viva voce exam of Moot Court. This is unjustified. There has to be minimum passing criteria for viva voce exam as well as for internal term work. It is to be clarified that, whether the External Supervisor appointed for Viva-voce exam can assess and consider Moot Court diary for giving marks? I think yes, External has to be given discretion to assess the diary.
5. **Minimum period of 'Observance of Civil Trial (Point B) and for Criminal Trial (Point C)** – Minimum period of observance of civil trial and criminal trial has to be mentioned clearly. In my opinion, minimum period shall be 15 days for civil trial and 15 days for criminal trial. It has to be authenticated by the Certificate of attendance signed by Advocate.
