
In concluding session interaction took place with students. Students have shared their views and opinions. Students have given positive feedback towards the admission procedure implemented in the college.

Thus the discussion between the officers and the students was successfully organized by our college team members. All the doubts, queries so asked by our students were answered satisfactorily.



Also the feedback about the session was collected from all the participants to improve the sessions that will be conducted in the mere future. The sample details collected from the participants is as follows:



One Day Workshop on “An Introduction to AECC”


Thursday, 28/11/2019


Activity – I

One Day Workshop on “Stress Management”


