## Best Practice- 1:

### Samaj Prabodhan Saptah (Social Awareness Week) 8<sup>th</sup> – 13<sup>th</sup> January

#### 1. Title of the practice:

#### Samaj Prabodhan Saptah (Social Awareness Week) 8<sup>th</sup> – 13<sup>th</sup> January

#### 2. Objective of the practice (100 words)

The Institution has successfully implemented various social awakening programmes under the title of the “Inspirational Week” from 8<sup>th</sup> -13<sup>th</sup> January every year. These programmes are organised with a view of the following objectives:

1. To organise programmes which creates inspirations in the minds of the students and staff.
2. To organise social awareness programmes in the nearby villages, schools and colleges.
3. To inculcate cherished constitutional values and morals among the masses.
4. To sensitize the students and citizens about the variety of socio-legal issues and organise relevant programmes
5. To contribute towards the social transformation through legal education.

#### 3. The Context (150 words)

In the month of January every year, the Institution initiates for the organisation of various inspirational speeches and social awakening activities. These programmes are organised on the occasions of the birth anniversaries of Hon. Dr. Patangrao Kadam (8<sup>th</sup> January), founder of Bharati Vidyapeeth, Pune and Hon. Secretary, Dr. Vishwajeet Kadam (13<sup>th</sup> January). Dr. Patangrao Kadam is an ideal and an all-time inspirational personality to all members of Bharati family. He established this institution with the prime motto of ‘**Social Transformation through dynamic education**’. Hon. Dr. Vishwajeet Kadam (13<sup>th</sup> January), Secretary, is also performing his functions in the same directions of his father.

January is also observing as the remembrance of the birth anniversaries of many social reformers, such as, **Krantijyoti Savitribai Phule Jayanti** (3<sup>rd</sup> January), **Rajmata Jijau Jayanti** and **Swami Vivekanand Jayanti** (12<sup>th</sup> January), **Netaji Subhash Chandra Bose Jayanti** (23<sup>rd</sup> January) who have contributed their life, towards social reforms, social transformation and national service.

#### 4. The Practice (400 words)

Initially, the Institution has started this activity in the name of “Prerana Saptah” (Inspirational Week). During this week, number of social activities are organised. The following practice is generally followed for conducting these activities which create inspirations in the minds of students and staff.

In order to celebrate ‘Samaj Prabodhan Saptah’, the Institute prepares a plan and sent it for sanction by the management. Prime importance is always given to co-curricular and extra-curricular activities, outreach and extension activities which are meant for social awareness. After getting approval of the plan, the college takes initiative to conduct the programmes.

For indoor activities, the resource persons are invited to deliver inspirational speech on the given schedule. For conducting outdoor social awareness programmes, the faculty and students



visit to the nearby schools, colleges and villages. After the consent of the concerned authorities, the faculty conduct the programme. Social awareness activities are conducted with the help of the students and faculty. During the last five years, the Institution has conducted various activities like GK Test, Guest Lectures, Legal awareness programmes in Schools and nearby Villages, Blood Donation Camp, Health Check-up camp, Tree plantation, etc.

On the occasion of celebration of 75 years of Independence Day, the Constitutional awareness activities were conducted under the head of “Azadi ka Amrut Mahotsav” of India. Through this campaign, the college faculties have visited various schools and colleges, self-help groups, Bachat gat etc. and delivered lectures on the constitution of India. The college was successful in delivering variety of topics like – Making of the constitution, Constitutional values and ethos, Fundamental Rights, Fundamental Duties of citizens, etc.

During the pandemic situations also the Institution has organised many activities through the online platform. For Example, during 2021-22, the Institution has conducted two online Inspirational speeches and one online inter-collegiate Elocution Competition. Hence, the week is celebrated continuously in every academic year. In 2022-23, a number of activities have increase to celebrate the week in comprehensive manner.

#### **5. Evidence of Success (200 words)**

The college has successfully conducted various activities under the ‘samaj prabodhan saptah’ for the benefit of masses. Through this activity we have been able to reach in different schools and colleges situated in different parts in Satara and Sangli districts.

We have received letter of thanks, letter of appreciation from different schools and colleges. We come to know that legal education is very much required for sensible citizenry.

#### **6. Problem of Encounter and Resources Required (150 words)**

If the affiliating University declares examination during this period of January month, the Institution face a problem to conduct such activities during examination period. In case of resources, generally, financial resources are bared by the Institution, but if more funds are required, the management provide the same for conducting social awareness activities. Hence, the management provides financial and other support for the success of activities under the Samaj Prabodhan Saptah.

#### **7. Notes (150 words).**

Social awareness of legal information, specifically, Constitutional values, fundamental rights and duties are essentially aware by each and every citizen of India. Students also get inspiration from the remembrances of the great social reformers. Hence, such activities are necessary to conduct in every educational institution.

### **Best Practice- 2: “Lead College Scheme”**

#### **1. Title of the practice**

“Lead College Scheme”

#### **2. Objective of the practice (100 words)**



The Lead College Scheme has been successfully implementing in the Institution during the last many years. A Lead College scheme functions with **the motto, "Efforts of each and welfare of all"**. The objectives of this practice are as follows:

- 1) To organise the Seminars, workshops / Conferences with collaborative efforts of the cluster colleges.
- 2) To share the Human resources, information, infrastructure, etc.
- 3) Organization of students' cultural & Sports activities.
- 4) Organising programmes relating to the Career guidance and placement cell in system of HE.
- 5) Organising FDP and Training workshops for Administrative Staff
- 6) Any other activity to fulfil the motto of the scheme.

### 3. The Context (150 words)

The Lead College Scheme is introduced by Shivaji University, Kolhapur for equality, assurance and excellence in Higher Education. The outline says, "One of the most significant measures of Total Quality Management in Higher Education is the concept of 'Lead College'."

Under this scheme, the University identifies and forms a homogenous cluster of 10 to 15 colleges fostering inter- institutional co-operation for overall development of all of them which is the basic principle. The University's mission is to make our colleges and the institutions of HE (Higher Education) achieve nationally and internationally acceptable standards.

This Institution has been selected as a 'Lead College' amongst all other law colleges affiliated to Shivaji University, Kolhapur. The Institution has been functioned as lead college during last four years from 2019-20 to 2022-23.

### 4. The Practice (400 words)

The scheme is functioning on the basis of the guidelines, rules and regulations of University's defined outline. After selection as the Lead College by University, the Institution had set up the "Lead College Working Committee". Its role is to monitor all other law colleges. The following practices has been following:

#### A. The Role of the Lead Activity Working Committee

The major role of the Lead College Working Committee is to look after the administration of the Lead College cluster, budgets/accounts/programmes, the proper records of the meetings, proceedings etc. It should facilitate the smooth functioning of the Lead College programmes.

Accordingly, the Working Committee discussed the policy for the conducting the lead activities at college level. It prescribed rules in this regards and communicate to all clusters. In the beginning of the academic year, it invited proposals from other law colleges. The Working Committee scrutinised all the proposals received and gave approvals for conducting the activities. If necessary, essential changes are made in the proposal to avoid multiplications of the activities.

During the pandemic situations, the committee conducted meetings on online platform and changed its policy & rules so far as conducting online activities. Due to the positive efforts of the Working Committee, the motto of the scheme was fulfilled in full capacity. It received and gave approvals to the expenditure, occurred for conducting the lead activities, submitted by



law colleges. The working committees sent the utilization certificates every year after getting it audited from the practitioner Chartered Accountant.

### **B. The Practice for conducting Lead Activities -**

The Institution has appointed a faculty as a coordinator for dealing with all required functions for the conducting lead activities in the college. The role of the co-ordinator is to look after all correspondence from the other cluster law colleges and lead college.

Every year, the co-ordinator prepared a proposal after discussion with the Principal and all other teaching staff members and submitted it to the Lead College for its approval. After the approval from the lead college, the co-ordinator proceeded for organising the activities as per sanctioned proposal. After receiving the convenience of the concerned resource person/s, the lead activity is scheduled. Thereafter, the coordinator sends letter of invitations to all cluster colleges for participation of the students or staff as the case may be. The activity is conducted by preparing a well-planned programme sheet, hospitality, feedback, etc.

After conducting all proposed activities, the coordinator sent the expenditure statement for its approval.

#### **5. Evidence of Success (200 words)**

A number of lead activities conducted by inviting well-known resource persons who were experts in the topic of the program. Some of the activities like - Workshop on Advocacy Skills, Research Methodology, Women Empowerment, etc. conducted through online platform as well as face to face method. The scheme is the best example for sharing the information and knowledge through the practice of the faculty and student's exchanges.

Law students and staff members are highly benefitted through this activity. Nearly 15 activities have been conducted under this scheme, wherein more than 500 students are participated during last five years. The interactions of the faculty and students made them to develop the global capabilities.

The regular and effective implementation of the lead activities continuously from last 15 years and the positive feedbacks given by the participants itself proves the success of this practice as one the best practices.

#### **6. Problem of Encounter and Resources Required (150 words)**

Sometime the funds sanctioned amounts are very less for conducting the activities. Some of the colleges are at remote places, e.g. the distance between Kolhapur and Phaltan is about 165 kms. Hence, it affects the participants to attend the programmes at such places. The travelling expenditure of the participants are increasing day by day. The funds for the activities are collected from all the students, but the benefits of the out-door activities are obtaining to very few students. The issues need to be considered and the rules are to be revised accordingly for arranging more activities and programs for the benefit of students and staff.

#### **7. Notes (150 words).**

The concept of Lead Scheme is adopted from the foreign universities. Shivaji University, Kolhapur has taken initiative to adopt it for the overall development of the students and staff. Other university may adopt and implement such schemes in positive manner for the holistic development of the students and staff.
